

DECLARATION

- I. I S/O/D/O
Student of (Course & Branch) hereby undertake to abide by the rules and regulations laid down by University for hostel residence.
- II. I hereby undertake to make good discipline, hygienic environment in hostel. I will never be involved in any type of indiscipline activities.
- III. I hereby assure that I will not indulge myself directly or indirectly in any form of anti-social and prohibitive activities such as “Ragging” or any kind of harassment, physical or otherwise. I am fully aware of the provision of Indian Panel Code relating to offence connected with causing injury, endangerment of life or personnel safety, wrongful confinement, assault and criminal intimidation. If I am found indulging myself in any such prohibitive or anti-social activities, I am liable for severe punishment including expulsion from the University and handing over to the police.
- IV. I further declare that I am not involved in any criminal activity and no such case pending against me in any court of law.
- V. I undertake that the fees once deposited will not be refunded in any case.
- VI. I hereby declare that I shall abide by the above mentioned conditions, rules/regulation and other guidelines as provided by the university/hostel administration from time to time including vacation of hostel for any specific task/order issued by central/state govt./district administration.
- VII. I am aware that the following are strictly prohibited in the University Hostels.
- a) Presence of any obscene literature, viewing of porn/erotic sites on computer. If such things happen the student concerned may be expelled from the hostel.
 - b) If a student is found smoking, chewing pan or masala or possessing/taking liquor the student concern may be expelled from the hostel.
 - c) Shouting, screaming, unbecoming behavior, playing of loud music are not allowed inside the Hostel premises.
 - d) Electrical appliances such as tape recorders, water immersion coil heaters, gas stoves, iron boxes, hotplates, etc. are not allowed inside the rooms.
 - e) Any type of personal/political/religious function of celebrated shall not be organized at hostel premises.
- VIII. Female hostellers will have to provide the names, along with photo of 2 of their relatives who would be allowed to meet her or may be contacted in case of emergency. The student will also have to explicitly mention their relation with him.
- IX. Presence of guardian is compulsory at the time of hostel allotments.
